#### **PARISH COUNCILLOR - VACANCY**

Following the election in May, the Parish Council still has a vacant seat, as only eight councillors were nominated and elected. This means that the Council is now free to co-opt another councillor to join their important work for the parish.

#### PARISH COUNCIL MEETINGS

Residents are encouraged to attend the monthly public Council meetings which cover general matters and also planning applications.

There is no meeting in August but the next full Council meeting takes place on Monday, 6 September.

#### **HELP BECOME CARBON NEUTRAL**

The Tunbridge Wells borough wants to work towards climate change targets set out by the Government and environmental bodies. We can all do small things to help this but the Parish Council will continue to consider all its procedures and actions, including issues such as the number of times grass is cut and where to make changes to re-wild suitable areas.

## **DEFRILLATOR**

A defibrillator has been installed in the Village Hall entrance lobby. It is available for emergency use by anyone using the hall. If you are a regular user, the Parish Council will be happy to arrange training for its use so please contact the Clerk who will be able to let you know the next dates.

#### WAR MEMORIAL

The Parish Council has decided that the war memorial outside the Social Club should now be cleaned and restored. It is an important reminder of the sacrifice and service given by parishioners so we want it to look at its best. Work will be carried out over the coming months.

# **ALLOTMENTS**

Please contact the Clerk if you know of any landowner who may be prepared to make some land available to be used for allotments. The Parish Council has been on the look-out for some months but so far, no one has

been able to offer suitable space. Allotments are in short supply in the area and the Council has a list of people who would like to make use of an allotment.

# **CONSERVATION AREA MAP AND HOP PICKERS LINE**



A number of parish councillors recently joined the Hop Pickers Line Heritage Group to unveil two new information boards on the green. The conservation area map replaced an existing one unveiled in 2014, which had seen better days. The map shows listed buildings in the conservation area, which is the historic centre of the parish.

Funding towards this new map came from the remainder of a generous legacy from a parishioner which had also funded the new walkers map unveiled in early 2020.

The Parish Council also supported the Hop Pickers Line Heritage Group who produced an information panel which was also unveiled.

These maps show the history of the village and the development and changes in the area over many years, as well as being able to show visitors what an interesting place we live in.

# **HORSE CHESTNUT TREE**

The Horse Chestnut tree on the south west corner of the village green is in need of reduction in size and maintenance to ensure its safety. This will be carried out during late summer so do not be surprised when you see these works begin; they are being done to ensure the long life and health of the tree.

#### **HIGHWAY IMPROVEMENT PLANS (HIPs)**

Kent County Council now require parish councils to produce highway improvement plans which provide a list of the priorities for improvements to the Highways in the parish.

These are reviewed regularly by the Parish Council and some have been amended and added recently. Local

Borough Councils are working together to press for action on rural roads and safety.

# LOST PATHS AND PUBLIC RIGHTS OF WAY IN THE PARISH

This ongoing project is moving ahead with councillors reviewing all the old footpaths they have found and considering which are still used but have not been officially recorded. They have also met representatives from the local Ramblers Association who are keen to work with the Parish to record lost paths.
