Comments:	The PC accept the principal for needing a window in the first floor bedroom, but the proposed design of the window is not in keeping with the character of the

building in size or shape. May we suggest that the architect look at bedroom
1(south facing window) as a possible alternative design.
With regards to the window in the dining room, the PC would prefer to see a half
size window rather than a full length glazed screen, bearing in mind this is a
heritage building and should not pretend to have a door where one never existed.
The PC appreciates the need for light and would suggest a smaller window.
