Tunbridge Wells Borough Council is now inviting representations on the Horsmonden Neighbourhood Development Plan for an eight-week period from Monday 4 July 2022 until 5pm on Monday 29 August 2022. All representations received from this consultation will be forwarded to an independent Examiner appointed to examine the Neighbourhood Plan.

### LORRY WATCH

If you regularly notice lorries that are using unsuitable roads or not sticking to the limits and restrictions on our local roads, you may wish to consider joining 'Lorry Watch'. This is a scheme run by Kent County Council where information on lorries that are thought to be using unsuitable roads can be collated and passed on to Kent Police for further investigation. Kent Police can find the vehicle's registered keeper and if the vehicle is ignoring the legal limits and restrictions, the police will contact the company and warn them that if they continue it may result in formal action.
