PARISH PRECEPT 2025-26

At the January meeting, the Parish Council formally approved their precept request for the upcoming financial year. This request has since been acknowledged and confirmed by TWBC.

After careful consideration of the Council's financial requirements and budgetary commitments, it was agreed to request a precept of £127,330, which represents a 0.6% decrease for a Band D council tax property compared to the previous year. This adjustment reflects the Council's commitment to maintaining efficient service delivery while ensuring responsible financial management.

SPEEDWATCH - CAN YOU HELP?

Speedwatch is a community-based scheme where volunteers record the speed of passing vehicles in the area where they live. Around 90% of vehicles observed once by Speedwatch volunteers are not seen speeding again in the next 12 months.

We already have an active Speedwatch group in Horsmonden, who do a great job, but they are desperately in need of more volunteers.
