## 6. OTHER PLANNING MATTERS (Discussion only – No decisions)

Cllr Russell commented on the recent tree works carried out on Goudhurst Road in relation to the Bassetts Farm development, which involved a road closure. It was observed that very little visible progress appears to have been made.

Cllr Boon commented that she felt the tree works may have focused on the visibility splays, following complaints received from residents, rather than on the footpath works as originally indicated. The footpath works are understood to be scheduled for the school holidays in July/August.
